### DECLARATION BY VANILLA ACCOUNT HOLDER

I reserve the right to refuse a debit in my account that does not agree with the services received by me and I understand that any such claim submitted to the Bank within 30 days after payment date will be reversed accordingly by the Bank. I understand that any claims after 30 days will have to be raised directly with Vanilla Telecoms Ltd.

I understand that the Bank/Vanilla Telecoms Ltd. may terminate this debit instruction at its sole discretion by advising me and the Bank/Vanilla Telecoms Ltd. in writing. I shall inform the Bank and Vanilla Telecoms Ltd in writing if I wish to cancel this mandate. All arrears need to be paid before applying for this service.
